- A legally required document by Virginia State Code Section 15.2-2223














Chapter 11-Implementation | What is it?

- Implementation Tools:

Chapter 11-Implementation | Why is it Important?



- Serves as a measure of accountability
- Builds trust with the community
- Helps guide annual budgeting processes
- Helps ensure any statemandated responsibilities are met

Chapter 11-Implementation | What is Included?

Implementation Category

Categorizes each strategy into an implementation type

Responsible Party

Identifies who is responsible for implementing each strategy

Stakeholders + Resources

Identifies other resources/groups that will be helpful in implementation

Timeframe

The ideal length of time for each strategy to be completed

Cost

Identifies, in general terms, how costly it will be to implement each strategy
